
Dear Ms. Zemek,

As per our conversation on Tuesday, November 18 we discussed the negative e-mails that we had received as a result of our website, [www.injusticeunveiled.com](http://www.injusticeunveiled.com), some of which we consider terroristic threats. We are sending you a copy of the latest negative e-mail we received. It should put to rest any doubts as to where the other negative e-mails came from that we traced to St. Cloud State University.

Not only are we concerned about the terroristic implications regarding these e-mails but we are very concerned about the attitudes of students and possibly faculty at SCSU toward people with disabilities, especially mental illness. To say that you do not consider this a problem we find particularly disturbing. Students graduating with degrees in criminal justice and law enforcement with these ideas of bias and hate can only result in officers, judges, and attorneys with attitudes of discrimination and stigma towards people with disabilities.

We hope that you will consider this type of communication from your students as a definite serious problem that needs to be addressed.

I'm in the Criminal Justice program here at SCSU. When I'm an officer, and if your son assaults me, I won't hesitate to pull my gun on him. And I haven't even gone through the training yet. That's my reaction as a human being. If I get attacked by a dog, even if the dog is mentally ill, I'm going to kick that dog in the ribs for my own protection. And if you were there, you'd be saying that I should have let the dog bite me. Well, no. I won't let the dog bite me, but you sure as hell can.

Listen up! Stop wasting our time, stop peddling the idea that law enforcement is against you. Just stop, or move away. Plague another community with your false ideas of what justice should be.
